This Cochrane Review aims to assess the effects of contracting out healthcare services. Contracting out healthcare services may make little or no difference in people's use of healthcare services or to children's health, although it probably decreases the amount of money people spend on health care. We need more studies to measure the effects of contracting out on people's health, on people's use of healthcare services, and on how well health systems perform. We also need to know more about the potential (negative) effects of contracting out, such as fraud and corruption, and to determine whether it provides advantages or disadvantages for specific groups in the population.
